

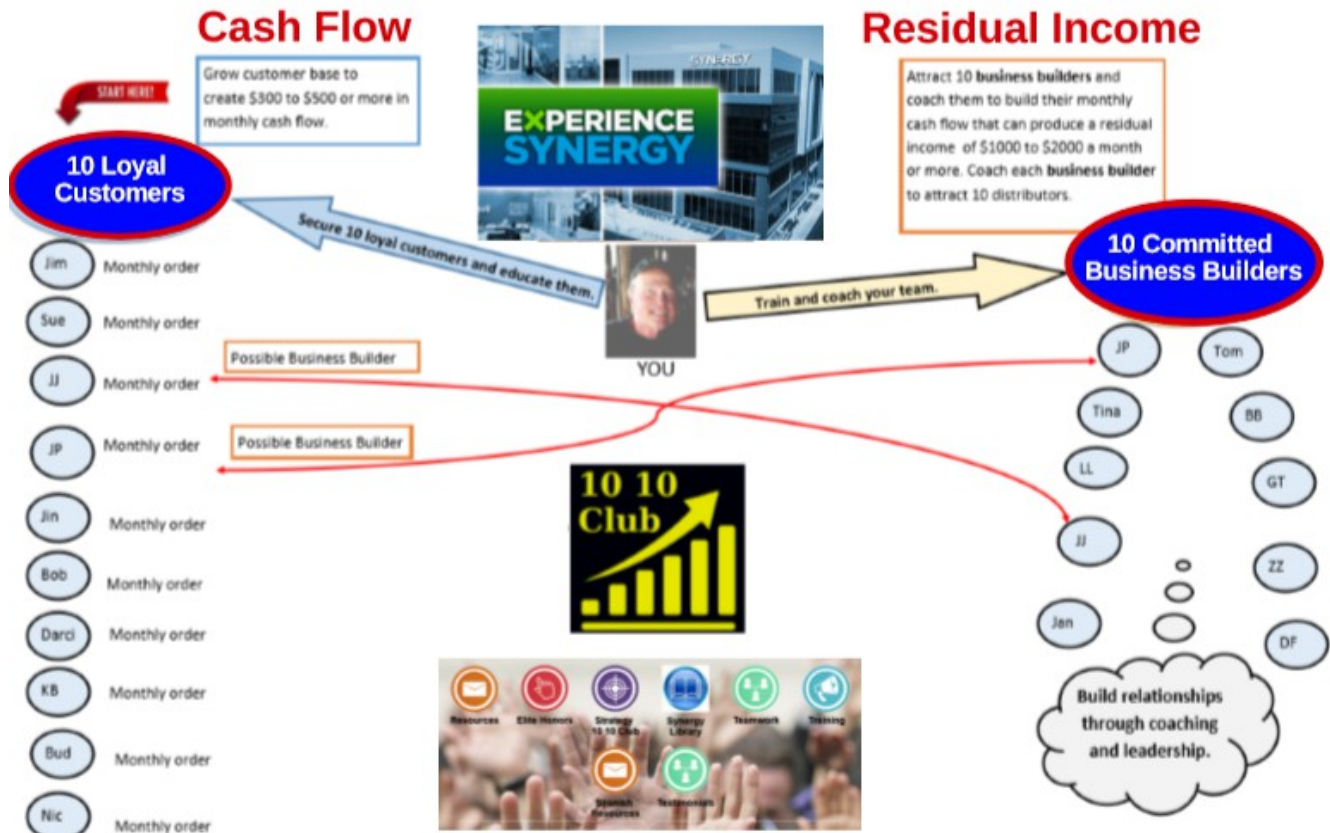

10 Loyal Customers Create Cash Flow

Goal: 10 Monthly Customer Orders

Average Order: 150 CV

Cash Flow Created Through Elite Rebates:

10 Orders x 150 CV/order = 1500 CV – 150 CV Threshold = 1350 CV
x 25% = **\$337.50 in Monthly Elite Rebates**

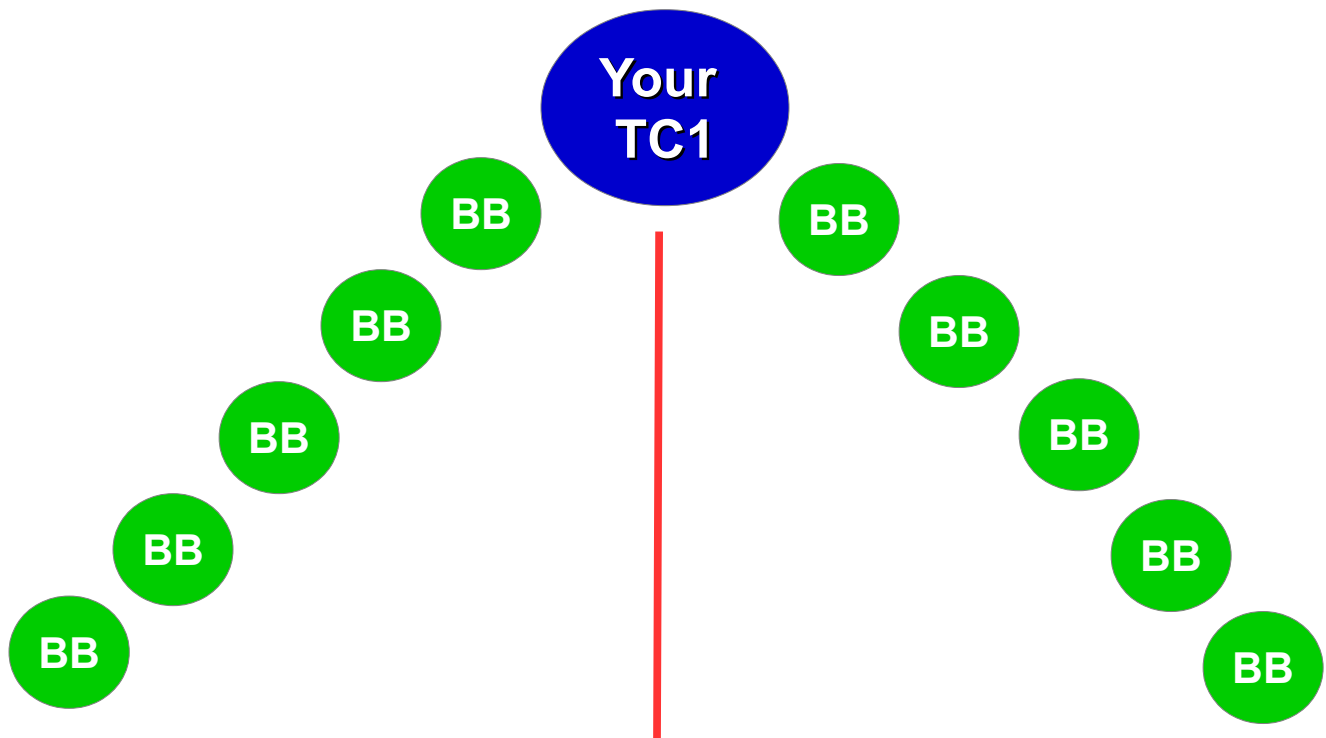
\$337.50 x 12 months = \$4,050 per year

Cash Flow to Run Your Part Time Synergy Business

10 Committed Business Builders Create Residual Income

Goal: 10 Committed Personally Sponsored Business Builders

(With proper sponsoring and placement 5 on your left side and 5 on your right side.)



Residual Income Created Through Business Builders

Average CV for each Business Builder if they have their 10 Loyal Customers creating cash flow for their Synergy business:

**1500 CV – 150 CV Threshold = 1350 CV divided by 2 = 675 CV
adding back in 150 CV Threshold = 825 CV**

825 CV x 5 Business Builders = 4125 CV for the month

Residual Income just from Basic Commissions

4125 CV x 7% = \$288.75
